## SUMMARY

- The final Offer Price has been determined at HK\$1.50 per Offer Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.003% and the Stock Exchange trading fee of 0.005%).
- Based on the final Offer Price of HK\$1.50 per Share, the net proceeds from the Share Offer to be received by the Company after deducting underwriting fees and estimated total expenses paid and payable by the Company in connection with the Share Offer, is estimated to be approximately HK\$116.0 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future Plans and Use of Proceeds” in the Prospectus.
- A total of 23,345 valid applications have been received pursuant to the Public Offer on **WHITE**, **YELLOW** and **PINK** Applications Forms and through giving electronic application instructions to HKSCC via CCASS and to the **HK eIPO White Form** Service Provider under the **HK eIPO White Form** service ([www.hkeipo.hk](http://www.hkeipo.hk)) for a total of 6,620,138,000 Public Offer Shares, equivalent to approximately 662.01 times of the total number of 10,000,000 Public Offer Shares initially available under the Public Offer.
- Due to the very significant over-subscription in the Public Offer, the reallocation procedures as described in the section “Structure and Conditions of the Share Offer – Basis of allocation of the Offer Shares – Reallocation.
